आयुर्विज्ञान में राष्ट्रीय परीक्षा बोर्ड (एनबीईएमएस), स्वास्थ्य और परिवार कल्याण मंत्रालय, भारत सरकार का एक स्वायत्त निकाय है, जिसे आधुनिक चिकित्सा के क्षेत्र में स्नातकोत्तर स्तर पर एक समान और उच्च स्तरीय परीक्षा आयोजित करने का कार्य सौंपा गया है। The National Board of Examinations in Medical Sciences (NBEMS) is an autonomous body of Ministry of Health and Family Welfare (MoHFW), Govt. of India, entrusted with the task of conducting uniform and high standard exams at Post Graduation level in the field of Modern Medicine.

2. एनबीईएमएस **यात्री लिफ्ट की स्थापना के लिए लाइसेंस प्राप्त और पंजीकृत फर्मों** से एकल चरण दो बिड प्रणाली (दो लिफाफा, तकनीकी बोली और वित्तीय बोली) के तहत लिमिटेड निविदा आमंत्रित करता है। बोली का यह आमंत्रण इस निविदा दस्तावेज में उल्लिखित पूर्व-योग्यता मानदंडों को पूरा करने वाले सभी बोलीदाताओं के लिए खुला है। NBEMS invites Limited Tender under single stage two bid system (2 Envelope, Technical Bid and Financial Bid) from licensed and registered firms for installation of Passenger Elevators. This Tender is open to all Bidders meeting pre-qualification criteria as mentioned in this Tender Document.

**A. कार्य का दायरा व तकनीकी विनिर्देश**  
**Scope of Work / Technical Specifications**

**1. Scope of Work**

- (a) Supply, Installation, Testing and Commissioning of Passenger Elevator of heavy duty with latest technology, gear less and machine room less type Elevator with carriage capacity of 6 passengers. The lift shall have 4 stops and 4 openings (Ground Floor, 2<sup>nd</sup> Floor, 4<sup>th</sup> Floor, 5<sup>th</sup> Floor). The elevator is to be installed at the following location:

National Board of Examinations in Medical Sciences  
PSP Area, Opposite Dwarka Courts,  
Sector-9, Dwarka, New Delhi.

- (b) Under this tender, the bidder shall mandatorily buyback the old passenger elevator installed in NBEMS. The bidder shall be required to dismantle old elevator and its accessories in a safe manner from the Building, without causing any damage to the building. Bidder is advised to inspect the old lift before bidding.
- (c) The bidder shall be required to perform renovation/restoration the Lift Well to a good condition before installation of new lift. The Cost towards the same to be included in the rates quoted by the bidder. No extra amount shall be payable for the same.
- (d) The Civil, Architectural and Electrical Works/Consultations (as required) to be arranged by the bidder at his own cost.
- (e) Obtaining of Permissions / License for erection/operation of lift shall be the responsibility of the bidder.
- (f) Bidder is advised to inspect the site for ascertaining the exact requirements of NBEMS and assess the Dimensions, Metrics of the lift well and technical specifications requirement.

**4. Removal of Existing Elevator and Restoration of Lift Well**

This tender includes buyback of the old lift installed in the Building. The bidder shall be required to dismantle the old elevator and its accessories in a safe manner from the Building, without causing any damage to the building. The bidder shall be required to perform renovation/restoration the Lift Well to a good condition before installation of new lift. The Cost towards the same to be included in the rates quoted by the bidder. No extra amount shall be payable for the same. Bidder is advised to inspect the old lift/site before bidding.

**5. Warranty & Free Maintenance**

The lift should carry atleast **24 months Comprehensive Warranty** and the bidder shall provide free maintenance during the said period. The Warranty Period shall begin from the date of completion of installation.

**6. Comprehensive Annual Maintenance (Post Warranty)**

Post Warranty, the Lift shall be covered under the Comprehensive Annual Maintenance Contract with the bidder. During the AMC period, the bidder shall provide routine Maintenance Services for smooth and safe operation of the Elevator.

**7. Documentation, Report and License**

The bidder shall be responsible for preparation of all documentation required for obtaining permission/license for erection and operation of lift. The bidder to study the site and prepare all necessary documentation, drawings etc. The Civil, Architectural and Electrical Works/Consultations (as required) to be arranged by the bidder at his own cost. Obtaining of Permissions / License for erection/operation of lift shall be the responsibility of the bidder. The bidder shall handover all the documents, reports, licenses, design documents, drawings, warranty certificates etc. to the concerned section of NBEMS in original, on Completion.

**8. Confidentiality:**

All documents, information, reports, drawings etc. relating to the assignment would be handled and kept strictly confidential and should not shared / published / supplied or disseminated in any manner to any third party.

**9. Delivery Timelines:**

- (i) General Arrangement Drawings (“GAD”) to be submitted by the successful bidder within 2 weeks from the date of Award of Contract.
- (ii) Completion of Installation: Within 3 Months from the date of approval of GAD.

**B. पात्रता मानदंड / पूर्वापेक्षाएँ**  
**Eligibility Criteria / Pre-requisites**

The bids of only those firms will be considered which satisfy the following eligibility criteria:

- i. The Bidder should be registered with the Appropriate Authority and have Income Tax Permanent Account Number (PAN) and GST Registration.
- ii. Bidder should have Necessary License from appropriate authority for carrying out installation of Passenger Elevators.
- iii. Bidder should have **OEM Authorization** from the Legally Valid Elevator Manufacturer Company.
- iv. **Experience:** The Firm should have experience of Installation of Passenger Elevator in Government Organizations during last 3 years and should have executed atleast:
  - a) **One work** not less than **80%** of Estimated Cost.
  - or*
  - b) **Two works** each costing not less than **50%** of Estimated Cost.
  - or*
  - c) **Three works** each costing not less than **40%** of Estimated Cost.
- v. The Average Annual Income (during last 3 years) of the Firm in the last 3 financial years should be minimum Rs. 18 lakhs (Rupees Eighteen Lakhs).
- vi. **Proposal/Synopsis Document:** Bidder to submit a proposal document indicating detailed specifications of the proposed Elevator, its technology, design, safety features, details of mandatory compliances, execution plan etc. NBEMS shall verify the proposal document of each bidder from a Technical Expert. Only technically passed proposals shall be considered for further evaluation, failing which the bids shall be disqualified on Technical Grounds. The **bidder may inspect the site between 10:00 am to 05:00 pm on working day, before the last date of submission of bids.**
- vii. Bidder should not be black listed by any Government departments, PSUs or any other organization in respect of any assignment or behavior. A certificate in this regard required to be submitted as per format in (**Form IV**).
- viii. Bids not satisfying the above eligibility criteria / not accompanied by the requisite documentary proofs shall be rejected on Technical grounds and shall not be considered further for evaluation of Bids.

All the documents are mandatory; failure to submit any document will result in disqualification of the bid at technical bid stage only.

## C. बोलीदाताओं के लिए सामान्य सूचना और निर्देश

### General Information and Instruction to the Bidders

#### 1. Submission of offers

The Bidder shall submit their proposals in two parts i.e. as **Technical Bid** & **Financial Bid**, as mentioned below:

- i). The tender is a single stage 'Two Bid' document. The **Technical Bid** should contain all the relevant information and desired enclosures in the prescribed format (Form – I). The **Financial Bid** should contain only price Bid (Form – II). In case, any bidder encloses the financial bid within technical bid, the same shall be rejected summarily.
- ii). All information called for in the enclosed forms should be furnished against the respective columns in the forms. If information is furnished in a separate document, reference to the same should be given against respective columns in such cases. If any particular query is not applicable, it should be stated as 'Not Applicable'. However, the bidders are cautioned that not giving complete information called for in the tender forms or not giving it in clear terms or making any change in the prescribed forms or deliberately suppressing the information may result in the bidder being summarily disqualified.
- iii). The Tenders should be typewritten. There should not be any overwriting, cutting, or interpolation. Correction, if any, shall be made by neatly crossing out, initialing, dating and rewriting. The name and signature of bidder's authorized person should be recorded on each page of the application. All pages of the Tender Document shall be numbered and submitted as a package along with forwarding letter on agency's letterhead.
- iv). Bidders must keep their offer open for a minimum period of 90 days from the date of opening of the tender, within which the bidders cannot withdraw their offer. However, this period may be extended further, if required, by mutual agreement from time to time.
- v). References, information and certificates from the respective clients certifying technical, delivery and execution capability of the bidder should be signed and the contact numbers of all such clients should be mentioned. The NBEMS may also independently seek information regarding the performance from the clients.
- vi). The bidder is advised to attach any additional information, which he/she thinks is necessary in regard to his/her capabilities to establish that the bidder is capable in all respects to successfully complete the envisaged work. The Bidder is however, advised not to attach superfluous information. No further information will be entertained after Tender Document is submitted, unless the NBEMS calls for it.

- vii). **Incorrect or misleading information:** If the bidder deliberately gives incorrect or misleading information in their tender or wrongfully creates circumstances for the acceptance of the tender, NBEMS reserves the right to reject such a tender at any stage and appropriate administrative action would be taken by NBEMS.
- viii). Even though agency may satisfy the qualifying criteria, it is liable to disqualification if it has record of poor performance or not able to understand the scope of work etc.
- ix). The Tender Document can be downloaded from NBEMS's web site ([www.natboard.edu.in](http://www.natboard.edu.in)) or Central Public Procurement Portal (<https://eprocure.gov.in/> and be submitted 'offline'.
- x). The Technical and Financial bids should be kept separately in sealed envelopes and both of these envelopes should be kept in one Master Envelope, super scribing **"Tender for Supply, Installation, Testing and Commissioning of New Passenger Lift (elevator) and Buyback of old Non-serviceable Passenger Lift"** so as to reach proposal to **The Honorary Executive Director, National Board of Examinations in Medical Sciences, NAMS Building, Ansari Nagar, New Delhi - 110029** **before the Last Date mentioned in the Tender Document.** Late tenders shall not be accepted. The technical bid shall be opened as per schedule mentioned above, in presence of bidders who may like to be present.
- xi). Apart from the original quotation to be submitted in the manner detailed above, no copies should be sent to any other office of NBEMS. Such offers will not be valid quotations. Offers not submitted in the standard formats given in the Tender Document will be summarily rejected. NBEMS shall not be responsible for any postal delay or non-receipt / non-delivery / incomplete Bid documents. No further correspondence on this will be entertained.
- xii). The payment shall be in Indian Rupees and shall be paid only after successful completion of work without error and delays as per the procedure mentioned in the Tender Document. No advance payment shall be made.
- xiii). Bidders are neither allowed to join hands to participate in the tender nor allowed to submit multiple bids. Bidding by the firms having common partners will be treated as multiple bids. In case of detection of such, their bid (s) is/are liable to be rejected. Bidding through consortium is not allowed.
- xiv). NBEMS reserves right to award the work/cancel the award without assigning any reason. In case of differences, if any, the decision of the NBEMS shall be final. The contract can be terminated at any point of time, in case of unsatisfactory service.

## 2. Price Quotation

- a) Bidder shall indicate prices as specified in format at **Annexure II**.
- b) All prices/rates should be clearly written both in figures and in words. Failure to write prices/rates both in figures and in words shall render the tender liable for rejection. Bidders should avoid alterations/corrections in the prices/rates submitted by them. However, if alterations / corrections in prices/rates are inescapable each alteration / correction should be indicated both in figures and in words and duly attested under the full signature of the Bidder / Authorized Signatory.
- c) In case of a discrepancy between the prices/rates in figures and words, the prices/rates in words will be considered correct.
- d) The prices/rates quoted shall be firm throughout the period of the validity of the offer and shall not be subject to any variation/revision.

## 3. Security Deposit/EMD

- a) All Bids must be accompanied by Earnest Money Deposit in the form of Demand Draft issued by any scheduled/nationalized bank drawn in favor of 'National Board of Examinations in Medical Sciences'.
- b) Bidders seeking exemption being an MSE, must attach relevant proof alongwith their bids.
- c) Performance Security deposit shall be as per guidelines of Govt. of India.

## 4. Acceptance of offer

NBEMS reserves the right to accept any bid under this tender in full or in part, or to reject any bid or all bids without assigning any reason.

## 5. Evaluation Process

- a) Detailed technical evaluation shall be carried out by Tender Evaluation Committee pursuant to Technical prerequisite /criteria and other conditions in the Tender Document to determine the substantial responsiveness of each 'Bidder'. For this clause, the substantially responsive bid is one that conforms to all the eligibility terms and conditions (mandatory as well as preferable/optional) of the tender without any material deviation.

### i). Technical Proposal Evaluation:

- (a) As a first step, the Documents of each bidder would be evaluated against the eligibility criteria mentioned in the Tender Document and requirements of NBEMS.
- (b) Thereafter the **Proposal/Synopsis Document** submitted by each bidder shall be evaluated by the Technical Expert appointed by the NBEMS. Only technically passed proposals shall be considered for further evaluation, failing which the bid shall be disqualified on Technical Grounds.



- (c) The Bids having cleared during the evaluation process as indicated at (a) and (b) shall be declared as '**Technically Compliant**'. The bids of only Technically Compliant Bidders shall be considered for further processing.
- (d) The result of the Technical Evaluation and Dates of Financial Bid Opening shall be notified through NBEMS Website.

ii). Financial Proposal Evaluation:

Financial Bids of only Technically Compliant offers shall be opened at NBEMS Dwarka Office as per the schedule, for further scrutiny, evaluation, ranking and placement of contract.

## 6. Payment Terms

The payment shall be made against the services provided by firm, subject to the following terms and conditions:

- i). The payment towards New Passenger Lift (elevator) shall be made after successful delivery, installation and testing of the Elevator, in accordance with the Financial Bid submitted by the bidder and rates accepted by the NBEMS.
- ii). The payment towards the **Comprehensive Maintenance Charges (CMC)** shall be payable on Quarterly Basis at the end of each quarter, based on the satisfactory report from the Concerned Section of NBEMS.
- iii). No request for extra payment on account of increase in price on whatever account will be entertained.
- iv). The price offered by the bidders will be inclusive of all expenses/ cost. Only GST will be payable extra (if applicable).
- v). TDS shall be deducted at applicable rates as per norms.
- vi). NBEMS reserves the right to deduct amount from the bill raised by the firm as may be considered reasonable for unsatisfactory services or delay in providing of services or Liquidated Damages. The decision of NBEMS will be the final in this regard.

## 7. General clauses

a) **Penalty Clause / Liquidated Damage**

- i). Delay on part of Bidder in performance of its delivery obligations shall render the Bidder liable to the imposition of penalty, if an extension of time is not agreed upon.



- ii). If the delay adversely affects NBEMS in any way, the performance security deposit shall be forfeited and other legal action would be initiated as per terms and conditions of contract. The NBEMS may rescind this part of the contract and shall be free to get it done from any other agency at the risk and cost of the Bidder.

b) **Integrity Pact**

The Bidder should be willing to enter into an integrity pact with the NBEMS, not to resort to any corrupt practices in any aspect/stage of the contract. The Bidder should commit itself to the promise:

- i). Not to offer any benefit to the employees of NBEMS;
  - ii). Not to enter into any undisclosed agreement or understanding with other bidders with respect to prices, specifications, certifications, subsidiary contracts; etc.
  - iii). To disclose the name and address of agents and representatives in India and Indian Bidder to disclose its foreign principals or associates;
  - iv). To disclose any past transgressions committed over the specified period with any other company in India or Abroad that may impinge on the anti-corruption principle;
- Integrity Pact lays down the punitive actions for any violation.

c) **Confidentiality**

- i). The Bidder and their personnel shall not, either during implementation or after completion of the project, disclose any proprietary or confidential information to any third party relating to the services, agreement or the NBEMS's business or operations. The legal liability for breach of confidentiality by the bidder and its employees solely lies with the bidder.
- ii). All documents, information, reports, drawings etc. relating to the assignment would be handled and kept strictly confidential and should not shared / published / supplied or disseminated in any manner to any third party

d) **Resolution of Disputes**

- i). The NBEMS and the Bidder shall make every effort to resolve amicably by direct informal negotiation, any disagreement or dispute that may arise between them under or in connection with the Contract.
- ii). If, after 15 days from the commencement of such informal negotiations, the NBEMS and the Bidder are unable to resolve,

amicably a contract dispute, either party may require that the dispute be referred for resolution to the formal mechanism in all matters and disputes arising there under, the sole arbitrator shall be mutually agreed upon by the parties in writing, who shall decide the claim and its decision shall be final and binding on both the parties. However, during the period of doubt, disagreement or dispute, both the Bidder and the NBEMS shall ensure that the Project/contract continue in a normal way. Such doubts, disputes and disagreement shall not give any reason or freedom to either the NBEMS or the Bidder to interfere in or prevent normal functioning of the Project.

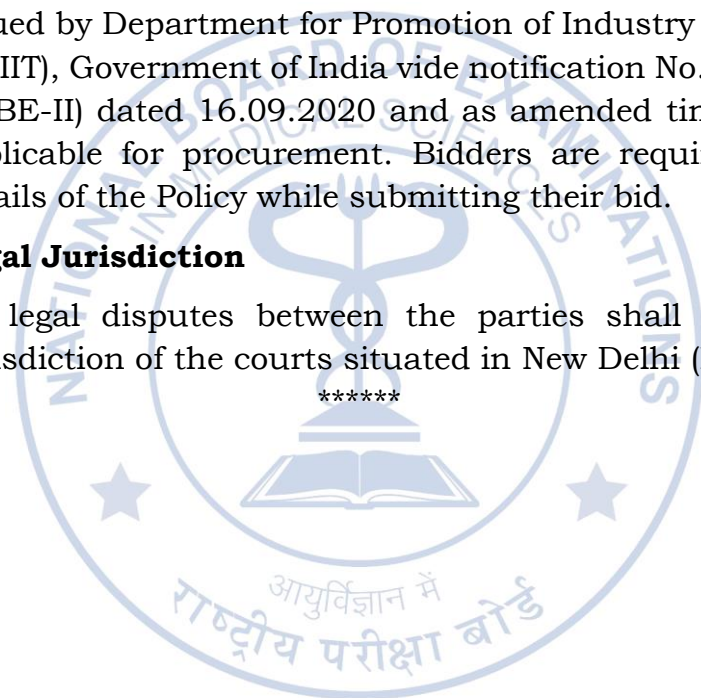
e) **PUBLIC PROCUREMENT (PREFERENCE TO MAKE IN INDIA) ORDER (PPP-MII Order)**
